: ORDER:

The Directorate of Enforcement has filed this complaint under Section 3 r/w Section 4 of the Prevention of Money-Laundering Act, 2002 (In short, PMLA 2002) against M/s ARK Imports Pvt. Ltd., Genex Infratech Ltd., Genex Polyfab Ltd. and Kailash Baburam Aggarwal.

2. Perused the record. It is claimed that M/s ARK Imports Pvt.

:2:

Ltd. indulged itself in criminal activities of acquisition of funds to the tune of Rs.532.85 Crore by conspiracy, falsification of documents, fraudulent trades, transacting non-existent goods, creating fictitious documents. By the said modus operandi, M/s. ARK Imports Pvt. Ltd. has acquired proceeds of crime to the tune of Rs.532.85 Crore by carrying out criminal activities relating to the scheduled offences, as defined under Section 2(1)(u) of PMLA 2002. The proceeds of crime were then further layered and used for their business activities, including purchase of raw materials, manufacturing, paying taxes and purchase of land.

- 3. M/s Genex Infratech Ltd. and M/s Genex Polyfab Ltd. indulged in acquisition of the proceeds of crime as defined under Section 2(1)(u) of PMLA 2002 from M/s ARK Imports Pvt. Ltd. to the tune of Rs.50.62 Crore and Rs.17.95 Crore respectively.
- 4. As per the provisions of Section 70(1) of PMLA 2002, the company is liable as legal entity for the contravention of the provisions of the law.
- 5. Kailash Aggarwal, Director and Controller of M/s ARK Import Pvt. Ltd., M/s.Genex Infratech Ltd. and M/s Genex Polyfab Ltd. has indulged himself in criminal activities of acquisition of funds to the tune of Rs.532.85 by carrying out criminal activities relating to the scheduled offences. He has layered and laundered the proceeds of crime used for his business activities, including purchase of raw material, manufacturing, paying taxes and purchase of land in the name of his group companies. The specific role and the acts are satisfied in the complaint.

From the contents of the complaint, it prima facie reflects

that accused Nos.1, 2 and 3 in the capacity of company and accused

:3:

No.4 in personal capacity managing the affairs of accused Nos.1, 2 and

3-company, have committed the offence under Section 3 punishable

under Section 4 of PMLA 2002. There is sufficient material on record to

take the cognizance of the offences under Section 3 r/w Section 4 of

PMLA 2002 against accused Nos.1 to 4.

7. Accused Nos.1, 2 and 3 are the companies and liable for

prosecution under Section 70(1) of PMLA 2002 and these companies

are managed and administrated by accused No.4, who is already in

custody before this Court. Hence no specific orders are required for

issuance of process/summons against accused No.4. Therefore

following order.

1. Cognizance under Section 3 r/w Section 4 of PMLA 2002 against

accused Nos.1 to 4 is taken.

2. As accused No.4 is in custody and already received the copy of

complaint, and additionally he is managing and administrating accused

Nos.1 to 3 – company, no separate order for issue process/summons is

required against the accused.

3. However, to avoid any technicalities, fresh process/summons be

issued against accused Nos.1, 2, 3 and 4 r/o 16/02/2017.
