The Hon'ble Supreme Court was pleased to dismiss the SLP(Crl.) No.2903/2020, filed by DGM Developers Pvt. Ltd. with regard to property situated at 'Khata/Khatauni No. 2/2, Khasra No. 2/8 and 2/9, Vilage Mauja Bharari, Tehsil and District Shimla, Himachal Pradesh vide its order dated 14.12.2020

White Water Foods and the DGM Developers are owned by Kamal Kant Dewan and Amit Dewan and the subject property was given by them in the undertaking.

NSEL intervened to oppose the reliefs sought in the SLP by DGM Developers and brought out their conduct before the Apex Court through its intervention application and arguments in the course of hearing.
