Heard the learned Advocates appearing for the parties and the following Order is

passed :

- Report No. 38 filed by the High Court Committee was accepted by this Court vide order dated 27th June, 2018. The liability of Defendant No. 1 i.e. P D Agro Processors Pvt Ltd against Plaintiff, National Spot Exchange Ltd (NSEL), has been accepted for Rs. 591,01,98,350.40/-.
- Report No. 42 filed by the High Court Committee was accepted by this Court vide order dated 6th August, 2018. The liability of Defendant No. 1 i.e. P D Agro Processors Pvt. Ltd. against Plaintiff, National Spot Exchange Ltd (NSEL), has been accepted for Rs. 42.75 crores/-.

- None present on behalf of Defendant No. 1. The present suit stands decreed in favour of Plaintiff being NSEL and against Defendant No. 1, P D Agro Processors Pvt. Ltd. for Rs. 633,66,98,350.40/-. The rate of interest payable by Defendant No. 1 shall be 9% p.a. from the date of accrual of the cause of action/default.
- 4. The Plaintiff shall file their claim with the Resolution Professional of Dunar Foods Limited and the same be considered.
- 5. The Suit is disposed off. However, the Plaintiff reserves its rights to pursue the suit against Defendant Nos. 2 to 20 in accordance with law in the event of the Plaintiff being unable to recover the decretal amount against Defendant No. 1. Hence, suit as against Defendant Nos. 2 to 20, shall revive if the Plaintiff is unable to recover the decretal amount from Defendant No. 1.
- 6. The sealing of decree is dispensed with under Rule 314 of the Bombay High Court (Original Side) Rules.
